

Resolution No. 22-003

**A RESOLUTION OF THE BOARD OF DIRECTORS OF THE BOARD OF
PUBLIC WORKS OF THE CITY OF LEWES ESTABLISHING FEES AND
RATES FOR UTILITY SERVICES WITHIN AREAS SERVED BY THE
BOARD OF PUBLIC WORKS**

WHEREAS, Section 4.1, *among other provisions*, of the Charter for the Board of Public Works of the City of Lewes (the "Lewes BPW"), being Chapter 10, Volume 77, Laws of Delaware, as amended (the "Lewes BPW Charter"), grants the Lewes BPW authority, responsibility, supervision, and control over current and future utility systems established within the Lewes BPW Service Area;

WHEREAS, Section 4.11 of the Lewes BPW Charter authorizes the Lewes BPW to fix rates, assessments, and fees for utility systems;

WHEREAS, such rates, assessments, and fees shall be sufficient for the Lewes BPW to provide the infrastructure, employees, equipment, and other resources necessary to operate said utility systems and for payment of debt services incurred by the Lewes BPW;

WHEREAS, Utility Financial Solutions, LLC ("UFS") conducted a financial analysis of the current Lewes BPW utility service rates and based on that analysis, has recommended that the Board of Directors of the Lewes BPW (the "Board") increase the rates for the utility services over the next five years; and

WHEREAS, after review and discussion of UFS's findings, the Board deems it in the best interest of the Lewes BPW and the ratepayers to increase the rates associated with electric, wastewater, water, and stormwater utility services over the next five years to allow the Lewes BPW to continue to provide the excellent, responsive, personal, and cost-effective service the ratepayers have come to expect.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE LEWES BOARD OF PUBLIC WORKS, IN SESSION MET THIS 6TH DAY OF APRIL, 2022, THAT:

Section 1. The utility rates for the Board of Public Works of the City of Lewes shall be established as provided in Exhibit "A" attached hereto and incorporated herein.

Section 2. The rates included in the charts for 2022/2023 in Exhibit A will take effect immediately upon adoption of this Resolution and will be applied to bills beginning in May 2022.

Section 3. The rates included in the charts for 2023/2024 in Exhibit A will be applied to bills beginning in May 2023.



For any Customer served under this Rate Schedule, this rate will cease to be applicable if the annual peak metered demand exceeds 50 kilowatts. In such case, the Customer will be changed to the Industrial rate.

This Rate Schedule shall be applicable for service to school's orphanages, stores, hotels, rooming houses, apartment houses, theaters, etc., and all other use that is not strictly residential or domestic home or farm use in character when annual peak demand is below 50 kilowatts. Any establishment carrying a business, professional, or commercial telephone directory listing may be considered as such in determining the applicable Rate Schedule, but the absence of such listing shall not be considered as conclusive in establishing the appropriate Rate Schedule.

Where one premise with annual peak demand under 50 kilowatts is used, and occupied by a consumer as a commercial establishment and also as a Residence, all service supplied will be billed under this Rate Schedule, or the wiring may be separated (subject to approval by the Board of Public Works) and each electric service metered and billed separately in accordance with the applicable Rate Schedule.
