Dear Richard,

SPRiG is pleased to provide the following proposal to furnish labor, equipment and necessary materials to complete the following scope of work in Lewes DE.

SPRiG Scope of Work

Force Main Bypass Connection and Valve Insertion

- SPRiG to remove clam shells (as cleanly as possible and stockpile)
- SPRiG to excavate down on the existing 8-inch DIP force main creating an excavation measuring approximately 8ft x 8ft x 5ft deep. Excavated soils will need to be hauled away then returned once the work is complete to avoid contaminating the shell driveway. SPRiG will need a location to stockpile soil then haul back to the site as needed.
- SPRiG to furnish and install an 8-inch EZ Valve (valve insertion). Valve to be located on the pump station side of the excavation.
- SPRiG to furnish and install an 8x6 Tapping Sleeve and Valve that will be located on the Lewes side of the excavation.
- SPRiG to furnish valves and fittings to create a 6-inch bypass connection off the 6-inch tapping valve.
- SPRiG to backfill area and re-install the clam shells.

Pump Station Suction Lines Bypass Connections

- SPRiG to excavate between the pump station and Pilottown Road on the existing 8-inch DIP suction lines creating an excavation measuring approximately 7ft x 7ft x 4ft deep. All excavated soils will be stockpiled just to the north of the pump station in the lawn area.
- Lewes / Inframark to furnish and install bypass equipment from existing wet well to the newly constructed force main bypass connection.
- SPRiG to cut and remove sections of both 8-inch suction lines
- SPRiG to furnish and install new 8-inch inline gate valves and 8x6 tee assemblies with 6-inch gate valves to serve as new suction bypass connections for PS 3.
- SPRiG to furnish necessary fittings to create a 6-inch bypass connection for both suction lines.
- SPRiG to backfill and restore the area with topsoil & seed restoration.
